- International Competitive Bidding will be conducted in accordance with ADB's <u>Single-Stage: One-Envelope</u> bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications, should participate in the bidding:
  - that the Bidder has successfully or substantially completed at least two (2) contracts within the last five (5) years and that are similar to the proposed works, where the value of the Bidder's participation exceeds USD 8.0 Million for each contract.
  - that the Bidder has a Minimum Average Annual Turnover of USD 8.0 Million calculated as total certified payments received by the Bidder for contracts completed or under execution over the last three (3) years.
  - that the Bidder must demonstrate that its financial resources less its financial obligations for its current contract commitments meet or exceed the total requirement for the Subject Contract of USD 1.0 Million.
  - that the Bidder have at least two (2) contracts in the last three (3) years that demonstrate construction experience on infrastructure related activities such as water supply, waste water, storm water, power, communications, lighting, landscaping with total value of at least USD 3.0 Million.

The qualification criteria are more completely described in the Bidding Documents.
